## NOTICE TO BIDDERS

Craven County shall open bids for a COUNTYWIDE CURBSIDE RECYCLING PROGRAM on Friday, April 8, 2011 at 11:00 a.m. in the Commissioners' Room located in the Craven County Administration Building at 406 Craven Street, New Bern, North Carolina.

Proposal information may be picked up at the Solid Waste Department at the same address from 8:00 a.m. - 5:00 p.m. Monday through Friday.

The Craven County Board of Commissioners reserves the right to reject any or all proposals for any reason and to award the contract to the Bidder they deem to be in the best interest of the County.

I. Information to Bidders

**A. Intent of Proposal**

Craven County is soliciting written proposals from qualified contractors to collect, process and market recyclable materials including but not necessarily limited to paper products, aluminum products, steel cans, clear, green and brown glass containers and PETE and HDPE (including colored HDPE) containers from residential dwelling units and hand commercial establishments in Craven County, North Carolina.

**B. Basis of Proposal Selection**

Craven County solicits proposals based on the specifications attached. The County shall evaluate proposals and award a contract in the interest of suitability to the County's needs, ability and experience of the contractor, inventory of contractors' equipment to be used in this project, and cost to the County (service other than the lowest price may be selected). The contract shall be with Craven County.

Besides these criteria, the County shall judge the contractor based on its willingness and ability to help the County in distribution of publicity and promotional material and willingness and timeliness to respond to and resolve complaints about collection of recyclables.

The County reserves the right to reject any or all bids, waive technicalities and be the sole judge of suitability of the services for the use by the County for the intended purposes.

**C. Receipt and Opening of Proposals**

All proposals shall be submitted to the Solid Waste Department Office, 406 Craven Street, New Bern, NC 28560 on or before 11:00 a.m. April 8, 2011. Bidders shall seal and plainly mark the envelope containing the proposals "Proposal for Countywide Residential Curbside Recycling Services for Craven County" and shall bear the name and address of the bidder. If forwarded by mail, bidders shall enclose the sealed envelope containing the proposal in another envelope addressed as specified. Proposals shall be publicly opened and read at the time and place specified above.

Any proposal may be withdrawn before the scheduled time for the opening of the proposals. Any proposal received after the time and date scheduled shall not be considered.

**D. Selection Process and Method of Award**

Immediately following the deadline for receipt of proposals as stated above, the County shall analyze and review all proposals submitted. Following the review, the County shall make a recommendation for award of the contract to the Board of County Commissioners.

**E. Preparation and Evaluation of Proposal**

All proposals must be prepared in ink or typewritten and signed by the contractor. If a dollar figure already entered by the contractor on the proposal form is to be altered before the bid opening, it shall be crossed out in ink and the bidder shall enter the new dollar figure above or below it, and the bidder shall initial the new dollar figure in ink.

**II. Instruction to Bidders**

Before submitting the bid, each bidder shall examine the Bid documents thoroughly. Bidders shall also become familiar with local conditions that may in any manner affect the performance of work. Finally, bidders shall be familiar with federal, state and local laws, ordinances, rules and regulations affecting the performance of the work.

**A. Required Information**

At a minimum, each firm shall include the following information in its proposal on the forms provided in the RFP or when form(s) are not provided, in the narrative as necessary.

1. A list of key personnel who shall be involved in the operation and management of this project. Include functions and resumes of each person listed. See form I.
2. A description of similar work experience and the names and phone numbers of contact persons, i.e., references. See form F.
3. Proposed subcontractors (if appropriate). See form G.
4. A detailed description of the services to be provided which displays understanding of the scope of services necessary. This description shall include the detailed method and schedule for collection of recyclables. See form- J.
5. A proposed method of continuing the current pick up schedule. See Attachment 2
6. A list of markets or market commitments that the contractor presently has for selling recyclables collected. See form E. NOTE - Trade secrets or proprietary information submitted by the contractor in connection with this Request For Proposals shall not be subject to public disclosure under the North Carolina Freedom of Information Act; however, the contractor must identify the data or other material by page or paragraph number to be protected, and state the reason why protection is necessary.
7. A detailed inventory list of all equipment, materials and labor to collect, store, process and market recyclables for all the County's customers. See form H.
8. An implementation schedule for the recycling program. Contractor shall show a time line for distribution of bins, meetings, etc., necessary for starting the program.
9. Total program costs, See form A.

**B. Evaluation:**

**Craven County will evaluate proposals received based on:**

- 1. Experience with related programs.**
- 2. Ability to perform to the satisfaction of the County.**
- 3. Completeness of the proposal.**
- 4. Technical feasibility of the proposed collection and processing methods.**
- 5. Commitment to additional program promotion and marketing.**
- 6. Ability to meet the expected start-up date of the program.**
- 7. Cost.**

**C. Specific Information**

- 1. Name, Address, and Legal Status of the Contractor**

**Bidders shall properly sign the proposal in ink with the address of the contractor given. The legal status of the contractor, whether individual, partnership, or LLC corporation shall also be stated.**

**The President or a Vice-President shall execute bids by corporations in the corporate name or accompany other corporate officers by evidence of authority to sign. The corporate address and the state of incorporation shall be above the signature. If the corporate seal is not available when the proposal is submitted, a substitute facsimile copy or certified letter may be submitted.**

**A bid by a partnership must be executed in the partnership name and the bid signed by a partner. His or her title must appear under his or her signature and the official address of the partnership and the names of all partners shall be typed or printed below the signature.**

**The owner will execute bids other than by corporations, LLC or partnerships of said firm submitting a bid in the presence of a Notary Public whose signature and seal attest a said signature.**

**If the proposal is a joint venture, consisting of a combination of any of the above entities each joint venturer shall execute the proposal. Anyone signing the proposal as an agent of another or others shall submit legal evidence of their authority to do so with the proposal.**

2. **Total Cost**

Proposed costs shall be based on 43,290 residential dwelling units and hand-commercial units. This is the number of units being charged for recycling as of January 1, 2011. Craven County shall adjust this number annually (July) based on tax records. A list of all known units, by area, is included as attachment 1. Bidders shall give costs per unit, per month. Contractor shall provide service to all dwelling units and hand-commercial establishments in Craven County.

3. **Inter-Local Agreements and County Code**

Craven County currently offers curbside recycling pick up within municipalities through an inter-local agreement with each municipality in Craven County. This is done according to NC G. S. 153A- 122. (... the governing board of a city may by resolution permit a county ordinance adopted pursuant to this Article to be applicable within the city. A city may by resolution withdraw its permission to such an ordinance. If it does so, the city shall give written notice to the county of its withdrawal of permission; 30 days after the day the county receives this notice the county ordinance ceases to be applicable within that city). During the current contract period (November 1, 1996 - present) all municipalities in Craven County except Bridgeton, (approximately 260 units) which contracts for their own recycling program, have signed inter-local agreements to participate in the curbside recycling program and none have shown any desire to withdraw from participation. This is subject to the conditions of Chapter 32 of Craven County Code of Ordinances.

4. **Invoices**

The contractor shall submit billings monthly and will be based on 43,290 units. Craven County shall make payment within thirty (30) days after receipt of an invoice and an accurate report of the material collected. Craven County shall not make payment until adequate, verifiable records of materials collected are submitted. Craven County shall require receipts for sale of materials quarterly in February, May, August and November and with the annual report for this contract. Discrepancies between materials collected and sold must be explained in writing.

5. **CPI Adjustment**

Starting July 1, 2012 all compensation rates payable to the Contractor under this agreement shall be adjusted annually to reflect the amount of the increase or decrease in the Consumer Price Index as measured by the United States Department of Labor, Bureau of Labor Statistics, South Region—All Urban Consumers (CPI-U). The rate shall be adjusted on an annual basis to be effective July 1 of each year.

The first adjustment shall be for the fiscal year beginning July 1, 2012 and shall use the January 2011 CPI as compared to the January 2012 CPI to compute the adjustment with the rate being adjusted by a percentage equal to the percentage change in the CPI. The January CPI is being used to allow for County's budgeting process.

Contractor shall invoice County for service rendered within five (5) calendar days following the end of the month. County shall pay Contractor, on or before the 30<sup>th</sup> day following the end of the billing period.

6. **Pre-proposal Conference and Request for Addenda**

Craven County shall hold a pre-proposal conference on March 18, 2011 at 11:00 a.m. in the Commissioners' Room of the Craven County Administration Building, 406 Craven Street,

New Bern, NC to review this RFP and to answer any questions. The County shall send any addenda to this RFP (if issued) to all those to whom it has provided the RFP. All requests for clarification or changes to this RFP will be directed in writing to Mr. Rusty Cotton, Solid Waste Director. No oral communications from any representatives of municipalities or the County will be considered in any way binding. The County will issue any changes or clarifications to all prospective bidders as formal addenda.

### III. Special Provisions

#### A. Purpose and Introduction

Craven County has had a countywide residential curbside recycling program in place since November 1, 1991. It is our desire to continue this program.

All materials collected in the recycling program shall be collected, processed, and marketed by the contractor. Collection shall be done in a manner in which contamination is minimized. Recyclables shall not be commingled with solid waste. Landfilling of these materials shall be prohibited except for material contamination. The contractor must report any landfilling of contaminated materials in writing, with detail to Craven County, attention: Solid Waste Director. It is understood that there is a difference in contaminated materials and residual materials. Contaminated materials i.e., a load of plastic contaminated by motor oil or a load of glass contaminated by a rock, would have to be reported if landfilled. A buyer would have rejected these loads. Disposal of residual materials, i.e., noncompliance materials accidentally picked up at the curb and discovered at the materials recovery facility would not have to be reported.

The contractor is scheduled to begin actual collection of recyclables under this contract on July 1, 2011. The time following the award of this contract but preceding the anticipated start date can be used for education, outreach, site preparation and planning. Craven County requires collection from dwelling units and hand commercial establishments (defined as any commercial entity disposing of less than 3 cubic yards of solid waste per week and not receiving dumpster service) to begin at the program start date. A list of all known hand commercial establishments is included as attachments 4-A and 4-B.

Craven County may propose and require one or more types of collection to adapt to site considerations for the multi-family units that are included. A list of all known multi-family complexes is included as attachment 4-C & 4-D. The number of drop off points per complex shall vary. The contractor must state in the proposal how recycling collection at each multi-family complex will be handled.

#### B. Specifications and Scope of Responsibilities

Craven County is seeking the services of a qualified firm or firms to collect, process and market materials recovered from the countywide residential curbside recycling program. Collection of recyclables shall be weekly.

1. **Materials Currently Accepted** - newspaper, corrugated cardboard, aluminum products, steel cans, clear, green and brown glass containers and PETE and HDPE (including colored HDPE). Proposals that include collection of additional materials are encouraged. If there are additional costs associated with collection of more materials, the bidder can submit them as an addendum to this proposal. They would then be subject to negotiation between the County and the contractor. If the contractor believes that the inclusion of additional materials in the original proposal can still be cost-competitive with others, the inclusion of these additional materials as part of the bid shall be considered favorably but not at the expense of added cost to the County. Attached, you will find an informational flyer on what is currently accepted in the program. The service described is the minimum of what is expected from the contractor. Alternate proposals for collection schedules will be considered by County.

Craven County reserves the right to redefine recyclable materials based on changes in Federal, State or local laws.

2. **Collection Schedule** - the contractor shall provide collection on a weekly basis or an alternative schedule based on a larger container size. Collections will not begin before 7:00 a.m. Recycling services shall be performed year round, excluding predetermined holidays (New Year's Day, Thanksgiving Day and Christmas Day) and with the exception of adverse weather conditions. The contractor shall give notification and consult with the County as such occasions arise. The contractor shall work with County staff to determine holiday and inclement weather pick up schedule modifications. Alternate proposals for collection schedules will be considered by the County for a 64 gallon covered, rolling container to be collected every two weeks Bid Form A-1.
3. **Recycling bins** - the contractor will provide and distribute, at its expense, collection containers for each unit. Each container will be able to withstand outside weather conditions and hold at least 18 gallons. The contractor will provide a sufficient number of containers to provide containers for all units; the contractor will provide additional bins at no cost to the County up to 5% annually of the number of units served. i.e., if the number of units is 43,290 the number of bins would be 2,165. The contractor must provide additional containers at the request of the county at no cost. The container shall have a clear designation as use for recycling. Each container shall have the County's name on it in an indelible fashion. Appearance and design of the container(s) are subject to the approval of the County. The inclusion of a restraining device on the bin, such as elastic, to prevent recyclables from blowing from the bin, as part of the bin shall be considered favorably but not at the expense of added cost to the County. Bidders must provide a prototype of the bin(s) to be furnished to the County. Craven County shall also consider alternate proposals for a 64 gallon covered, rolling container to be collected every two weeks Bid Form A-1.
4. **Collection procedures** - the contractor shall collect all properly prepared materials accepted by the program. Improper positioning of materials within the containers will not excuse the contractor from collecting the contents. Newspaper and other paper materials shall be considered acceptable for collection whether wet or dry. Improper contents, i.e., those materials not designated for collections, do not have to be collected and may be left in the container with a printed explanatory notice. Such notices must be developed and provided by the contractor. The contents of the notices shall be subject to the County's approval prior to printing for use.
5. **Road specifications** - Any road or drive with at least three (3) units shall be serviced. A smaller truck may be used for this purpose.
6. **Backdoor service** - the contractor will provide special backdoor collection service to disabled and/or elderly residents as identified by the County. The County shall relay all customer requests for such service to the contractor upon receipt. Currently, approximately 349 residents receive this service.
7. **Multi-family Complexes** - Development of the multi-family recycling drop off points may require screening and other construction to accommodate the containers and negotiation to meet the planning, parking, access, appearance, zoning and other requirements of the jurisdiction in which the site is found. The complexes themselves may also have appearance and other requirements. The

contractor shall have primary responsibility for ensuring the placement of sufficient containers at each complex. Containers used for multi-family dwellings must be maintained by the contractor in cooperation with apartment complex or mobile home park maintenance personnel so that they are available for recycling use. The County shall not accept any legal responsibility for any permits or fees required. The contractor shall furnish recycling containers, other than standard 18 gallon, required for Multi-Family Complexes.

The County shall not require that the contractor bear the expense of any required site modifications but the contractor shall be required to work closely with the complex managers to ensure proper and acceptable container placement.

8. **Response time requirements - the contractor must be able to respond within 24 hours of any contact from County regarding concerns of customers. The contractor shall be responsible for returning to an area that has been serviced for the purpose of collecting recyclables from a customer whose recyclables were missed. The contractor shall provide service as deemed necessary by the County. The contractor shall also provide the following to Craven County:**
  - a. **A contact person who shall be available at all times to answer the County's inquiries and respond to customer complaints. This person shall have ready access to crews throughout the collection day.**
  - b. **A telephone number for receipt of these complaint calls to be included by Craven County with all publicity furnished to participants in the recycling program. This requirement cannot be met through an automated phone answering system.**
  - c. **Documentation of all complaint calls received and how the complaints were resolved. This monthly record will be maintained for review and use by the county. Each complaint from Craven County Solid Waste Department, not addressed within 24 hours will result in a \$250.00 fine per day.**
9. **Public awareness - Craven County shall require that the contractor submit to the County for review any program it plans for public awareness activities to promote recycling participation. The County shall require that the contractor work with the County and the multi-family complex managers and maintenance personnel to provide accurate and proper recycling information to users or potential users, ensure professional appearance and behavior of its staff, including assurance that it shall reduce blowing trash and broken glass from its collections and generally promote recycling throughout the service area through the performance of its collectors and other support staff. The contractor shall assist the County by providing "house to house" delivery of printed information as provided and requested by the County.**
10. **Term of Contract - shall be through June 30, 2016 assuming that the performance of the contractor is satisfactory. The County has the option to extend the contract for an additional three year period.**

C. **Narrative**

**How do you propose to resolve conflicts from citizens regarding complaints from service issues?**

**Craven County requires that Churches and Volunteer fire departments receive the basic recycling service at no charge if they request the service. Additionally, Craven County Offices (all County government buildings**

maintained by Craven County) receive recycling service (including office paper and cardboard) at no charge. Attached, you will find a list of the Craven County Office Buildings and the number of 64 Gallon roll-out containers used to provide Recycling Services.

**D. Qualifications of the Contractor**

The County shall require certified supporting data regarding qualifications of the contractor with the proposal submittal to decide qualification and responsibility of the contractor. The contractor shall be required to furnish the following information:

1. Satisfactory evidence that the contractor's experience in a county or municipal government service or private business derives from operations of comparable size or larger to that contemplated by this proposal. Details shall include length of other contracts, name and size of the County(ies), the municipality(ies), subdivision(s) or businesses served, nature of services provided, and the name of the contact person at the municipality(ies), subdivision(s) or businesses in question.
2. Evidence that the contractor, is in good standing in the State of North Carolina and, with a corporation or LLC organized under the laws of any other state, evidence that the contractor is authorized to do business in the State of North Carolina or a sworn statement that it shall take all necessary action to become so licensed if the bidder accepts this proposal.
3. A detailed inventory listing of the contractor's equipment and personnel available and necessary for use on the contract and all accessories to be used in this project or as backup for this project by type, model, the year of manufacture and anticipated remaining useful life as of the date of the inventory. All new equipment to be acquired to accomplish this contract shall be the responsibility of the contractor. For new equipment, bidders shall attach delivery guarantees by manufacturers to the bid document. Service must commence as of the stated beginning date and be provided according to the terms of these specifications.

The contractor shall list the contingency equipment available in case of equipment failure of the specified equipment. Failure to obtain satisfactory equipment is a violation of this agreement.

4. If the contractor cannot begin any phase of the job at the agreed upon start dates, the County shall invoke a fine double the amount of the prorated cost of serving the locations not started on time. The costs of readvertising the start date in case of a delay that is the fault of the contractor shall also be borne by the contractor.
5. The names and resumes of the principal officers, partners and/or officials. The name(s), and resume(s) of the individuals who shall be considered in responsible charge of the County's contract.
6. Names, addresses and qualifications of any proposed subcontractors including past work done with the contractor.

**E. Disqualification of Contractor**

Although not intended to be an exhaustive list of the causes for disqualification, any one or more of the following causes among others may be considered sufficient for disqualification of a contractor and rejection of this proposal.

1. Evidence of bidding collusion among contractors.
2. Lack of competency as revealed by either financial statements, experience, or equipment statements as submitted or other source documents.
3. Lack of responsibility as shown by past work.
4. Default on any previous performance contracts within the past ten (10) years.

**F. Bid Bond**

No proposal shall be considered or accepted unless at the time of its filing a bid deposit shall accompany the same. This deposit may take the form of cash, a certified check, cashiers check, or bond and must be in the amount of at least five percent (5%) of the annual bid. The bond must be "executed by a corporate surety licensed under the laws of North Carolina to execute such bonds," conditioned that the surety shall upon demand forthwith make payment to the County upon said bond if the bidder fails to execute the contract according to the bid bond. Craven County shall retain and deposit this deposit to Craven County's account if the successful bidder fails to enter the proposed contract within ten (10) days after formal written notification or fails to give satisfactory surety as required herein. Bidders shall comply with this requirement carefully and specifically. Bank money orders, uncertified checks, telegraphic money orders, etc. are not acceptable as bid deposits. Bid deposits of unsuccessful bidders shall be returned when Craven County awards the contract.

**G. Performance Bond**

A performance bond in the form established by ( NC G.S. 44A-33) for \$750,000 shall be required of the successful bidder prior to the award of the irrevocable contract.

**H. Insurance Provisions**

A certificate of insurance must accompany each proposal stipulated as follows:

1. Worker's Compensation - Coverage to apply for all employees for statutory requirements according to the applicable state and federal laws.

2. **Comprehensive General Liability** - Coverage shall be minimum limits of \$1,000,000 per occurrence combined single limits for bodily injury liability and property damage liability. This shall include premises and operations, independent contractors, products and/or completed operations, contractual liability, broad form property damage, X,C, and U coverage, and a contractual liability endorsement.
  
3. **Business Auto Liability** - Shall provide for not less than a combined limit of \$1,000,000 per occurrence for bodily injury, liability and property damage liability. This shall include: owned vehicles, hired and non-owned vehicles and employee non-ownership.
  
4. **Special Insurance Requirements**
  - a. Craven County is to be included as additional insured on the Comprehensive General Liability policy.
  
  - b. Contractors shall maintain valid insurance policies meeting the above requirements for the duration of the project. The contractor shall send renewal certificates to the County 30 days before any expiration date. There shall also be a thirty (30) day notification to Craven County in case of cancellation or modification of any stipulated insurance coverage. Certificates of insurance on Accord 25 (eight/84) Form meeting the required insurance provisions will be forwarded to the County. Wording on the Certificate, which states that no liability shall be imposed upon the company for failure to provide such notice is not acceptable. The County may require original policies or certified copies of policies anytime.
  
  - c. It shall be the responsibility of the contractor to ensure that all subcontractors comply with the same requirements as the contractor.

The contractor shall include all subcontractors as insured under its policies or shall furnish separate certificates and endorsements for each subcontractor. All coverage's for subcontractors shall be subject to all of the requirements stated herein.
  
  - d. **Hold Harmless Agreement** - The contractor agrees to protect, defend, indemnify, and hold harmless Craven County from all loss, liability, claims or expense (including reasonable attorneys' fees) arising from bodily injury, including death or property damage to any person or persons caused in whole or in part by the negligence or willful misconduct of the contractor except to the extent the negligence or misconduct by Craven County causes same.
  
  - e. Shall the bidder encounter problems obtaining and/or meeting the County's insurance requirements, please be prepared to discuss at the pre-bid conference or contact the Assistant County Manager at (252) 636-6600 for guidance.

I. **Contamination**

All materials collected in this program shall be processed and marketed by the contractor. Landfilling of these materials shall be prohibited except material contamination. The contractor must report any landfilling of contaminated materials in writing, with detail to Craven County: Attention Solid Waste Director.

**J. Contract Compliance**

Craven County shall be responsible for monitoring the contractor to ensure they are providing specified services.

**K. Revenues**

The contractor will receive 100% of the revenues from the sale of recyclables.

**L. Public Awareness Campaign**

Before and ongoing during the program, the Contractor shall conduct a Public Awareness campaign with the assistance of other interested parties, including other jurisdictions, the County, and the multi-family complexes to promote the County's recycling programs. The program may use all available media and personal contact.

The contractor shall be required to meet on site with each multi-family complex manager at least once in the first month and again during each year of the term of the contract. The contractor shall submit a simple log of times, dates, locations and attendees at all initial meetings with the annual report.

The County shall work closely with the Contractor's staff regarding program operation and the Contractor's public awareness program to ensure the success of the County's recycling program.

**M. Reporting Requirements**

The contractor is required to keep accurate program records and submit reports to comply with the County's reporting requirements. These reports are extremely important, as they shall serve as a means to inform the County's staff of the status of recycling activities. The County also requires that the contractor provide certifiable, accurate monthly weight receipts for all materials collected in the County's program and marketed by the contractor. The contractor shall submit these records of sales of materials quarterly if they are not available monthly. Weight records will be kept using a scale inspected by the State of North Carolina Department of Agricultural Standards Division. A report of the County's curbside collection tonnage is included as Attachment 3. Reporting requirements include:

1. **Monthly Project Reports** - The recycling contractor shall submit monthly project reports for the length of the contract period commencing upon final approval of the contract. These reports shall be due within seven (7) working days from the end of the period being reported. The reports shall include:
  - a. **Summaries of the tonnages of all materials recovered by material type.**
  - b. **Material market prices.**

- c. List of all customer complaints including name, address, and date, nature of the complaints and how they were resolved.
  - d. Weekly set-out rates and monthly participation rates.
2. **Quarterly Reporting Requirements - The contractor shall provide quarterly project status reports. These reports shall be due within fifteen (15) days of the close of the quarter being reported (end of the reporting year will be June 30.) These reports shall include:**
- a. Summary of all program costs and revenue, tonnages recovered by material. The contractor must adequately explain any discrepancies in materials reported as sold and those reported as collected.
  - b. Discussion of problems and noteworthy experiences in program operation.
  - c. Suggestions for increasing participation and improving the program.
  - d. Summary of all complaint calls received by number and type.
3. **Annual Reports - The contractor will provide year-end annual reports for the year of record the project is in operation. This report shall be due within thirty (30) days of the end of the reporting year (end of the reporting year will be June 30). The report shall include:**
- a. A collated summary of the detailed costs and revenue information contained in the quarterly reports and summarize the participation rates and recovered materials' tonnages by type.
  - b. A discussion of public awareness activities and their impact on participation and recovered volumes.
  - c. A discussion of highlights and problems and measures taken to resolve problems and increase efficiency and household participation.
  - d. Summary of complaint calls by number and type.

**N. Projected Costs and Revenues**

In this bid proposal, the contractor shall provide a projected operation and maintenance cost budget for the recycling program. In addition, the contractor shall provide an estimate of projected revenues from the sale of recyclables. A report of tonnages associated with current program is attached. The costs and revenue budgets should detail the costs monthly for the length of the contract.

**O. Implementation Schedule**

The contractor shall include an implementation schedule for all start-up activities, significant project milestones and completion dates.

The start-up date for the County's recycling program under this contract is July 1, 2011.

**P. Liquidated Damages for Failure to Enter Into Contract**

Craven County deems the contractor as having been awarded the bid when Craven County mails formal Notice of Award and contract documents to the contractor by certified mail, return receipt requested.

The bidder to whom Craven County awards the contract shall be required to execute the contract within ten (10) days after receipt of a formal contract and notice of the award. If the contractor does not sign the contract within ten (10) days, Craven County may declare the contractor's proposal bid bond forfeited to Craven County as liquidated damages and the County may then make the award to the next best qualified contractor or the work re-advertised for proposals as Craven County may elect.



## Recycling in Craven County

### RECYCLING

- Aluminum cans
- Newspaper (with inserts)
- Clear, Green & Brown Glass
- #1 (PETE) Clear Plastic
- #2 (HDPE) Natural Plastic
- Rigid plastic bottles with the neck smaller than the body of the container  
**EXCEPT MOTOR OIL & PESTICIDE CONTAINERS**
- Corrugated Cardboard (Cut down to no larger than 2' x 3')
- Steel (tin) Cans
- Steel Paint Cans (empty & dry - no larger than 1 gallon)

An annual fee of \$36 is charged to residential dwelling units and small (hand commercial) businesses. The fee is placed on the annual property tax bill.

### Helpful Hints

- ✘ Empty & rinse all cans, bottles and containers. They don't have to be spotless but clean containers help eliminate odor and mess from your storage space.
- ✘ Remove lids from plastic bottles before recycling.
- ✘ It is not necessary to remove labels.
- ✘ Steel can lids should be put in the empty can. All other lids & caps are not accepted in the recycling bin.
- ✘ Step on your plastic containers. Flattened plastic takes up less space in your recycling bin.
- ✘ A heavy object placed on top of your recyclables will keep them from blowing away on a windy day.
- ✘ Paint cans must be empty and completely dry with lids removed.

Recyclables need to be placed out for collection before 7:00 a.m. on your scheduled collection day. If your collection day falls on a holiday observed by this program your recyclables will be picked up the following day. Observed holidays include, but are not limited to, Thanksgiving Day, Christmas Day and New Year's Day. Please call this office for confirmation of any schedule changes.



### PAINT EXCHANGE

Bring us your unwanted cans of paint (NO LEAD BASED PAINT PLEASE). The paint will be categorized and offered free of charge to the public. The paint is accepted at all sites but is distributed at the Bridgeton Convenience Center. The Paint Exchange is open from the first week in April through the weekend after Thanksgiving. This schedule is subject to change based on seasonal temperatures. Please call to verify opening and closing dates.

**Recyclables will be collected curbside in your 18 gallon green recycling bin or any other comparable container, easily identifiable as containing recyclable materials.**
