

## 2014 NOVEMBER 4 GENERAL ELECTION NOTICE

NOTICE IS HEREBY GIVEN pursuant to G.S. 163-33(8); Craven County residents who are not registered to vote in Craven County must register to vote by the **registration deadline on Friday, October 10, 2014, at 5:00 PM**, to be able to vote in the 2014 General Election on November 4, 2014. Voters who are previously registered need not re-register for this election. Any voter who has moved within Craven County since the last election should notify the board of elections in writing by Friday, October 10, 2014. A person is not qualified to vote in a precinct if you have not resided in that precinct for 30 days or more preceding an election. Out of Precinct voting is not allowed (G.S. 163-55).

Straight party voting is no longer available in North Carolina. The following contests will be submitted to the voters: US Senate; US House of Representatives-Districts 1 & 3; NC State Senate-District 2; NC House of Representatives-Districts 3, 10, & 12; District Attorney; Craven County Board of Commissioners-Districts 1, 2, 3, 4, 5, 6, & 7; Craven County Clerk of Superior Court; Craven County Sheriff; NC Supreme Court Chief Justice-Parker Seat; NC Supreme Court Associate Justices-Hudson, Martin, & Beasley Seats; NC Court of Appeals Judge-Hunter, Stroud, Martin, & Davis Seats; Craven County Board of Education-Districts 2, 4, & 6; Craven Soil & Water Conservation District Supervisor; NC Constitutional Amendment-To allow criminal defendants to waive jury trial by a judge except in cases where the death penalty is being sought. Absentee ballots are allowed. Requests for absentee ballots by-mail may be made in writing only on the State Board of Elections request form (see [www.cravencountync.gov/departments/elc.cfm](http://www.cravencountync.gov/departments/elc.cfm) or [www.ncsbe.gov](http://www.ncsbe.gov)) and received in the Craven County Board of Elections office no later than Tuesday, October 28, 2014 at 5:00 PM. Beginning Thursday, October 23, 2014 and ending at 1:00 PM on Saturday, November 1, 2014 One-Stop Absentee voting will be held in the Craven County Board of Elections One-Stop Training Room located in the Craven County Governmental Bldg at 406 Craven, Street, New Bern, NC. The hours of operation will be weekdays 8 AM until 7 PM, October 30 & 31 8 AM until 7:30 PM, and Saturdays, 8 AM until 1 PM. Additional four (4) Sites for the One-Stop Absentee voting will be: 1) State Farm Complex at 288 Hwy 70, Ste 102, Havelock, NC; 2) Cove City Fire Dept, at 425 S. Main St., Cove City, NC; 3) Rhems Fire Dept, at 5860 US Hwy 17 S, New Bern, NC; and 4) Vanceboro Fire Dept, at 375 NC Hwy 43, Vanceboro, NC. One-stop voting hours at all the additional 4 sites are weekdays 8 AM until 6 PM and Saturday, November 1, 2014 8 AM until 1 PM.

The absentee review board meetings will be held, pursuant to G.S. 163.230.1(c1), in the office of the Craven County BOE located at 406 Craven Street, New Bern, NC, at 4:30 PM on October 14, 2014, October 21, 2014, and October 28, 2014; at 5 PM on November 3, 2014 and November 4, 2014; and at 9:00 AM on November 14, 2014. Pursuant to N.C. G.S. §163-182.2 a random sample hand-to-eye count of paper ballots will be performed at 10:00 AM on November 6, 2014 and the provisional official ballots will be counted at 9:00 AM on November 14, 2014.

Canvass will be held at 11:00 AM, at the office of the CCBOE, on Friday, November 14, 2014. Other business may be transacted by the board at any of the scheduled election meetings.
