**NOTICE OF TEMPORARY TRANSFER OF  
VOTING PRECINCT**

Pursuant to North Carolina General Statute §163-128(a), the Craven County Board of Elections unanimously resolved to temporarily transfer, for the purpose of voting in the November 8, 2011, First Craven Sanitary District, Non-Partisan Election, voters from Precinct # 12(Truitt) and Precinct #20 (Fairfield Harbor) to Precinct # 11(Bridgeton).

Voters (eligible to vote in the First Craven Municipal Election only) currently assigned to Precinct #12-Truitt, that ordinarily vote at the Little Swift Creek Fire Department, or Voters (eligible to vote in the First Craven Municipal Election only) currently assigned to Precinct #20-Fairfield Harbour, that ordinarily vote at the Fairfield Harbour Fire Department & Community Center on Broad Creek Rd, will vote in the #11 – Bridgeton Precinct at the Tri Community Fire Department on Saints Delight Church Rd. in New Bern, North Carolina.:
