NOTICE OF TEMPORARY TRANSFER OF VOTING PRECINCTS

Pursuant to North Carolina General Statute §163-128(a), the Craven County Board of Elections unanimously resolved to temporarily transfer for the purpose of voting in the November 5, 2013 Municipal General Election:

- Voters currently assigned to Precinct #4 Rhems, that ordinarily vote at the Rhems Fire Department, Hwy 17 South, in New Bern, NC will vote at the #N6 West New Bern Precinct, West New Bern Rec. Center on Pinetree Drive, New Bern, NC.
- Voters currently assigned to Precinct #6 Clarks, that ordinarily vote at the West of New Bern Fire Department Station #3, Industrial Drive, New Bern, NC will vote at the #N6 West New Bern Precinct, West New Bern Rec. Center, Pinetree Drive, New Bern, NC.
- Voters currently assigned to Precinct #16 Grantham 1A, that ordinarily vote at the #7 Township Fire Department, Old Cherry Point Road, New Bern, NC will vote at the #23 Grantham 2B Precinct, Riverdale United Methodist Church, US Highway 70 East, New Bern, NC.
