BEVERAGE LICENSE APPLICATION

Application is hereby submitted for licenses in accordance with and in conformity to all provisions of the Beverage Control Act of 1937. If applicant possesses a State Permit, although he does not sell alcoholic beverages, he must purchase a County License, Complete and return this application along with your check or money order made payable to the Craven County Tax Collector.

§ 105-113.70. Issuance, duration, transfer of license.
(a) Issuance, Qualifications.- Each person who receives an ABC permit shall obtain the corresponding local license, if any, under the Article. All local licenses are issued by the city or county where the establishment for which the license is sought is located.
(b) Duration. - All licenses issued under this section are annual licenses for the period from May 1 to April 30.
(c) Transfer. - A license may not be transferred from one person to another or from one location to another.
(d) License Exclusive. - A local government may not require a license for activities related to the manufacture or sale of alcoholic beverages other than the licenses stated in this Article. (1985, c. 114, s. 1; 1998-95, s. 16.)

NOTICE

All beer and wine licenses expire April 30th. To avoid any inconveniences with the beer and wine inspector, we urge you to purchase your license from the Craven County Tax Department prior to May 1st. Please make all checks payable to the Craven County Tax Department.

Note: State law provides that any person who shall knowingly make any false statement in an application for this license shall be guilty of a misdemeanor, and upon conviction shall be fined and/or imprisoned as provided by law.

NOTARIZED SIGNATURE CERTIFIES THAT THE FOLLOWING ARE TRUE:

- 1. The applicant is a resident of North Carolina and is not less than 21 years of age except if a corporation holds the State ABC Permit then the manager/applicant is not less than 19 years of age.
2. The applicant has not had an outstanding final judgement entered against him/her in an action under Article 1A of Chapter 18B of the Alcoholic Beverage Control Laws.
3. The applicant within two (2) years has not had any alcoholic beverage offences or any misdemeanor controlled substance offence.
4. The applicant has not within three (3) years been convicted of a felony or had an alcoholic beverage permit revoked; or during the preceding license year, committed any act or permitted any condition for which his/her license has been revoked or suspended.
