



CRAVEN COUNTY TAX LISTING

NOTICE IS HEREBY GIVEN TO LIST YOUR PROPERTY IN JANUARY 2024

WHO MUST LIST

All persons owning taxable property in Craven County as of **January 1, 2024**

All property will be listed by electronic filing at www.cravencountync.gov/tax, in person at the Craven County Tax Department located at 226 Pollock St., New Bern, N.C., or by mail that must be USPS postmarked on or before January 31, 2024. **The Craven County Tax Department does not accept metered postmarked mail as timely if the listing is received by the Department after January 31, 2024, 5:00 p.m.** Forms submitted by mail in the provided return envelope are addressed to our listing service provider at PO Box 985, Mount Airy, NC 27030.

WHEN TAXES MUST BE LISTED

The listing will begin Tuesday, January 2, 2024, and will end Wednesday, January 31, 2024. The Tax Department is open from 8:00 a.m. until 5:00 p.m. Monday through Friday excluding holidays. A night depository is located at the right front corner of 226 Pollock St. in New Bern. Taxpayers may use this box to deposit tax listings and tax payments after office hours.

WHAT MUST BE LISTED

All personal property such as mobile homes, boats, boat motors, jet skis, aircraft and all unlicensed (un-tagged) vehicles, trailers, campers, motorcycles, semi trailers or trailers registered on a multiyear basis, all income producing personal property including farm machinery, and any new improvements, additions, or deletions to real property. Tangible personal property owned by an individual nonresident of this State shall be taxable at the place in this State at which the property is situated.

PERSONAL PROPERTY TAX RELIEF FOR ACTIVE DUTY MILITARY

If you are active-duty military stationed here and claim a state other than North Carolina and/or a county other than Craven County as your home of record, you are exempt from personal property tax here in Craven County. A current copy of your LES may be submitted to our Department as proof of your legal residence. However, a dependent (including spouse) who is non-military may be subject to personal property tax here.

TO AVOID LATE PENALTIES, THE LAST DAY FOR LISTING IS WEDNESDAY, JANUARY 31, 2024.
The Craven County Tax Department does not accept metered postmarked mail as timely if the listing is received by the Craven County Tax Department after January 31, 2024, 5:00 p.m.
