#### **VOTING INFORMATION**

#### Who can vote in this 2nd Primary July 9?

All Republican registered voters, Unaffiliated registered voters who voted a Republican ballot in the April primary and Unaffiliated registered voters who did not vote in the April primary are eligible to vote.

### Who is not eligible to vote in this 2nd Primary?

Democrat, Libertarian, Green, Constitution and Unaffiliated registered Voters who voted Democrat or Libertarian in the April 30 Primary. Ref. NCGS 163A-989; 8 NCAC 10B.0103

#### Absentee-by-Mail:

Voters may submit an Absentee-by-Mail request prior to the schedule established by law for the Board of Elections to mail out a ballot. Voters should be cautious to allow adequate time for the passage of their request and ballot through the mail. The Board of Elections will begin mailing ballots 50 days prior to Election Day for Primaries and General Elections AND 30 days prior for municipal elections. Again, it is in the best interest of the voter to submit a request for an Absentee-by-mail ballot as early as possible.

#### Requesting a ballot to be sent to you by mail

If it is more convenient for you to vote by mail, you may request an absentee ballot by mail by filling out the <u>required State Absentee Request form</u> which is found on our webpage, in our office, or the office can mail you one.

Request forms have to be requested and signed by the voter or a near relative can request for the voter. Note: A Power of Attorney is not allowed to sign for a voter or request for a voter.

The last day an absentee-by-mail ballot request can be received and processed is 5:00 pm on the last Tuesday before the election.

Once your request is received, it will be processed and your ballot will be mailed.

NOTE: <u>A request form must be received for each</u>
<u>election that a voter desires to vote an</u>

Absentee-by-mail ballot.

#### Request on behalf of near relatives:

If you qualify as a "near relative", you may request an absentee ballot by mail on the voter's behalf. To qualify as a "near relative", you must have one of the following relationships:

- Spouse
- Sibling (brother or sister)
- Parent
- Grandparent/Grandchild
- Child
- Mother/Daughter-in-law or Father/Son-in-law
- Stepparent/Stepchild

# You are required to identify the relationship in your request.

Absence for Sickness/Physical Disability: A voter or voters' near relative or legal guardian may go in person to the Board of Elections after the Tuesday before the election, but not later than 5 pm the day before the election, because of a voters' sickness or other physical disability and make a request for an absentee ballot.

## **One-Stop Absentee Voting**

One-Stop Absentee voting (Early Voting) is available beginning the 3rd Wednesday before and ending on the last Friday before Election Day. Times are determined by the Board of Elections and approved by the State Board of Elections before each election.

Same-day registration is not allowed in this election.

# **Election Day Voting**

Any eligible registered voter in the County can vote on Election Day <u>at their assigned precinct</u> (polling place) between the hours of 6:30 am until 7:30 pm. By law must have lived in the precinct area for 30 days or more to be able to vote in that precinct.



#### Voting an absentee by mail ballot

An absentee-by-mail ballot packet will include; an instruction sheet, a paper ballot, a return envelope.

It is very important for voters to fully <u>read the</u> <u>provided instruction sheet carefully</u>. All instructions need to be followed to ensure each vote is to be counted. These instructions will direct voters on proper writing instruments to be used in the proper marking of the ballot, remind a voter to have witnesses to sign and address the return envelope.

VOTERS MUST SIGN THEIR RETURNED BALLOT ENVELOPE AND HAVE ALL THE REQUIRED INFORMATION AND ALL SIGNATURES COMPLETED FOR THE BALLOT TO BE COUNTED

Note: POA's cannot sign for a voter-Voters' must make their own signature marks.

After marking the ballot, PLEASE place it in the return envelope and drop in the mail, with the proper postage, or you may personally deliver it to the Board of Election's office.

Ballots may only be returned in person or by a near relative of the voter. State Law.

#### **RETURN DEADLINE**

The deadline for a voted absentee-by-mail ballot to be received by our office is 5 pm the day of the Election.

Ballots are timely if postmarked by Election Day and received by 5:00 pm the Friday after Election Day.

#### **SAMPLE BALLOTS**

Available 50 days prior to an Election Day for primaries and general elections and 30 days prior to municipal elections.

Found on web page and copies available in the Craven Co. Bd of Elections office after ballots have been received.

Ballots are voter specific and are based on the voter's residence address and proper jurisdictions a voter is eligible to vote in.
